Transportation of children, youth and/or adults

Part A is for individuals who transport children, youth and/ or adults. A copy of the current insurance binder, or any type of paperwork from your insurance carrier, must be SHOWN or provided to the parish or school Transportation Facilitator. (Please contact the parish or school for the name of this individual.) The paperwork must confirm the insurance amounts are a minimum of 100/300/50.

Once a driver is approved as an "adult/child" driver, they are automatically approved as an "article" driver also.
